Channabasava Swamigalu Basvathirth Math Humnabad,
Dist.Bidar, and Virakathamatha Ingaleshwar, Taluka
Basavan- Bagewadi . Dist.Bijapur, hereby create this
deed of trust and declare as under;

1. That as per the wish and will of my Pujya

and other such activities, this deed of trust is made
for improving and carrying out further this Holy pre-

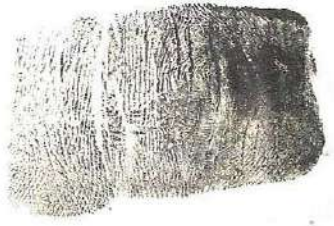

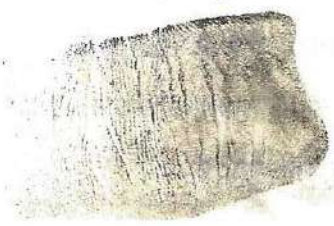

2. This trust shall have its area of operation over the entire country.

3. I hereby create this trust with following aims and objects.

1). Aims and objects;

a). To establish both educational and religious institutions such as Schools, Colleges and other similar educational institutions of various kinds, like Training, evening Colleges, Libararies etc.

b). To establish Hostels and Boarding homes for the comfort of students.

c). To train and educate bachelors (vatus) to become spritual heads.

d). To arrange services of Lecturers such as seminars to preach religious and moral principles. To print and publish books of Library , cultural, religious and scientific values, and to establish printing press for this object.

e). To honour to religious Reformers and Leaders and to encourage their social upliftment activities on special occasions.

- f). To put and make subjected to the rules and Regulations framed under this Vidyapeeth, if so desired to the Schools, Colleges and Hostels, as well as to other institutions run by the Trust.
- g). To run and manage the Colleges and Hostels by way of taking over, their management being run in other places, either by any other authorities or by the Government of the concerned State or States after making them subject to the rules and regulations of this Vidyapeeth.
- h). To provide research facilities and for publications of cultural, religious and social activities, like agricultural and other alike objects.
- i). To promote fine arts Industries, Agricultural and other alike objects.
- j). To undertake any business or businesses, Industries or any other enterprises including investment in and or acquisition of any immoveable or moveable properties, by purchase, lease, or on rent from any person or persons, whatsoever, for deriving revenue or augmenting the resources of the Trust for the above objects and to borrow funds with or without security for the effective conduct of the affairs of the business of the Vidyapeeth.
- k). To take all and every necessary steps to spread adult education for men and women belonging to the backward and all other communities of our Countries.



2). NAME AND STYLE OF THE TRUST:

All the affairs and transactions and activities of this Trust shall be carried out in the name and will be as "SRI JAGAD GURU SIDDABASAVESHWAR VIDYAPEETH TRUST BASVATEERTHMATH HUMNABAD AND VIRAKATH MATH INGALESHWAR". The word trust and Sangha, used in this deed shall mean the same.

3). TRUST FUND:

a). To meet out and to carry out the above objects of this trust the initial fund for the same shall be Rs. 1551/- (Rs. one thousand five hundred and fifty one-only).

b). To develop the fund of the trust we will have to decide and wish to pay the funds obtained from the moveables and immoveable properties or from the sale of such property as may be admissable.

c). To carry out the activities of this Trust I have deposited and wish that the donations, contributions issued from several public personalities be credited to this trust fund only.

d). Any amount if received from the Govt shall remain in the trust fund for the purpose and to carryout the activities of the trust and its objects. All the amount received in the above manner shall remain and be used in-furtherance of the aims and objects of the trust and it shall be known as Sri. Jagadevaru Siddabasaweshwar Vidyapeeth Trust fund.

4. ADMINISTRATION AND MANAGEMENT OF VIDYA PEETH:

The management and administration of the Vidyapeeth shall be carried on by its executive President (SIDDALINGADEVARU) with the help of the other members , in-consultation with the Honorary President Sri.Channabasava Swamigalu.

a). Any appointment to the trust or to its any institutions of any nature of staff or staffs , and removal as well as termination from the same, as and when needed and required to be made in order to carryout the functions of the trust and its institutions properly and regularly, as per the rules and regulations so framed in this regard by the trust, in-accordance with the timely prevailing provisions of law, rules etc, so enacted by the Govt. in this behalf, is also to be carried out and done, by the executive President in-consultation always with the Honorary President.

b). In order to assist to the Executive President for carrying out the aims and objects properly and regularly, of the Trust , five persons will be nominated as members to the Trust, by the Honorary President, of the trust. Such nominated members shall be continued in the trust as its members, for the period of the year or years till the same is desired to be continued in such capacity of the Honorary President of the trust.

c). There shall be a Secretary in the trust for working in the trust and his fixation of salary, appointment, removal etc, will be made by the Executive President.

d). The Executive President shall have the full authority to appoint any Teaching and non-Teaching, other staffs on the salary basis in order to carry out the aims and objects of the trust and to run all the nature of the institutions established under the trust.

e). Honary President shall have always power to change any rules and bye-laws as and when necessary to carry on the management and administration of the trust smoothly and effectively.

5. MEMBERS OF THE VIDYAPEETH:

Every Indian who has attained the age of majority is eligible to be a member of the Vidyapeeth, under the following catagory.

- i). Those who donates Rs.10,000/- and above shall be Maha Poshakas.
- ii) Those who donates Rs. 5,000/- and above shall be Poshakas.
- iii) Those who donates Rs. 2,500/- and above shall be Abhimani Sadasaya.
- iv). Those who donates Rs. 1101/- and 501/- shall be Sayaka Sadasya and Ajeeva Sadasyas respectively.
- v). Acceptance of the membership to the trust will be at the sole pleasure of the Honorary and Executive Presidents.



6. TERMS OF HONARARY AND EXECUTIVE PRESIDENTS:

Both shall be holding such posts till their life time and in case of vacancy, caused, the survivor will be the supreme authority of the trust.

7. The Executive President of the Trust shall have powers to establish any number of branches of the Vidya-peeth within the area of the trust where-ever he feels necessary, in order to promote the aims and objects of the trust and also to form local committee of the persons as deemed fit by him. Such of the local committee or its any members will be continued in office at the pleasure of the Executive President only.

8. That all the dealings in respect of moveable and immoveable propetties either to be acquired or to be disposed in the interest of the Vidyapeeth is to be made by the Executive President, always in consultation of the Honorary President only, according to the needs of the Trust and required facilities to the Trust and Vidyapeeth.

9. In order to carryout the affairs of the trust the Executive President is empowered to get sanctioned any loan from any of the local Banks and other financial authorities by way of mortgage of any of the trust property in their favour, only with the prior consultation to the Honorary President.



10. The Executive President shall be responsible for maintaining the accounts of the trust and Vidyaapeeth and that of all institutions of the Trust always and he should produce the same once in every six months for verifications and his satisfaction by the Honorary President., regularly . He has to get it audited always through the competent Auditor/s in order to maintain the proper accounts of all the funds received to the trust in either way .

11. That the acquisition of all the nature of properties for the trust and Vidyaapeeth, by the Executive President shall be only in the name of the Trust always.

12. All the funds of the trust should be deposited in any of the Schedule / or approved Banks by the Executive President in consultation with the Honorary President . Withdraws at a time , ~~and should be signed with the signature of Executive President to the extent of Rs. 100,000/- only (Rupees Twenty Five thousand only), and in case of withdrawls exceeding that amount, it should be signed with joint signatures of the Honorary and Executive Presidents always.~~ *Senth*

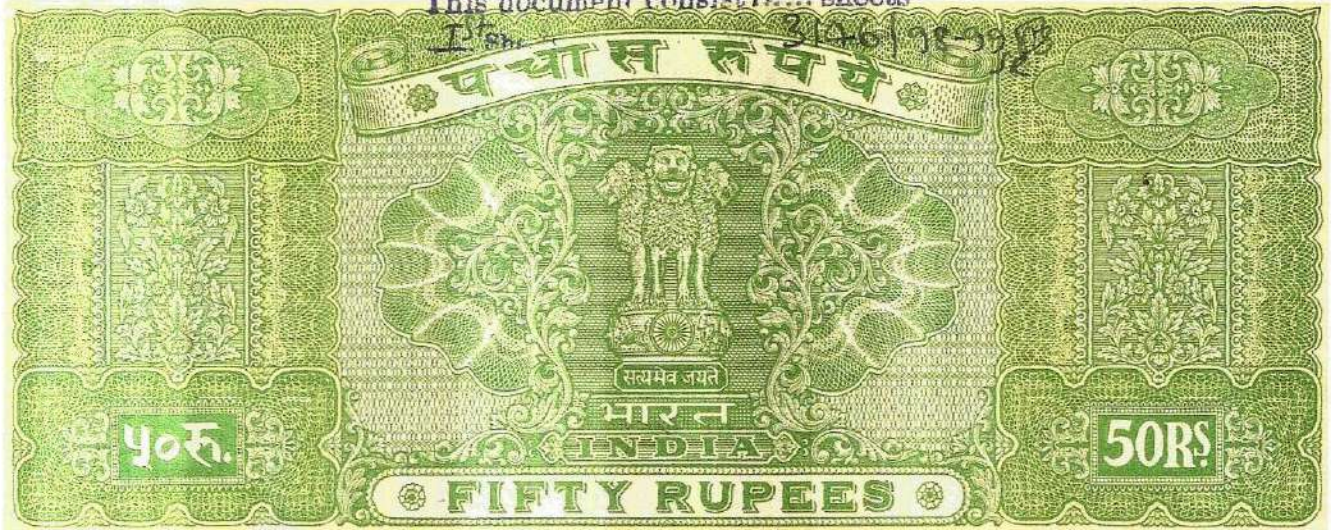
